### I. Introduction.

The achievement and independence of the Republic of Uzbekistan, as well as the current prudent policy in many areas, have created ample opportunities and conditions for the emergence and development of many new branches of legal education. These changes and radical reforms have led to the formation of several legal disciplines and disciplines, such as parliamentary law, banking law, tax law, insurance law, and human rights. In particular, human rights, its activities were developed, worked on the principle of humanity.

Human rights are the interrelationships between the state and the individual in relation to the observance and enforcement of the legal rights and freedoms of a particular person or persons by the state or officials. Violation of such relations, ie non-compliance with human rights laws, obstruction of citizens by officials by exercising their rights, or non-fulfillment by the state of its international obligations, is a violation of international standards by national legislation. such as inadequate compliance, leading to human rights violations in the country<sup>1</sup>.

obligations of the Republic of Uzbekistan in the field of human rights.

Effective mechanisms have been developed to monitor the observance of citizens' rights and freedoms, and consistent measures will be taken to develop cooperation with international and regional human rights organizations. At the same time, large-scale reforms in the country require further improvement of mechanisms for ensuring human rights and freedoms, effective implementation of international norms and standards in the field of human rights protection.

In order to increase the effectiveness of the National Center for Human Rights of the Republic of Uzbekistan, to create an effective system of implementation of international obligations of the Republic of Uzbekistan in the field of human rights, as well as five priority areas of development of the Republic of Uzbekistan in 2017-2021 In accordance with the objectives of the Action Strategy:

**The National Center for Human Rights of the Republic of Uzbekistan (hereinafter - the Center) cooperates with government agencies and other organizations in the implementation of international obligations of the Republic of Uzbekistan in the field of human rights, the preparation of national reports, human rights is a state body that provides for the expansion of cooperation with international defense organizations;**

**The Center exercises its powers independently of all government agencies and organizations, their officials;**

**The Center annually provides information to the President of the Republic of Uzbekistan, the Chambers of the Oliy Majlis of the Republic of Uzbekistan, the Cabinet of Ministers of the Republic of Uzbekistan on the status of compliance with international obligations of the Republic of Uzbekistan in the field of human rights.**

The Center assists government agencies, civil society institutions, educational, research and other organizations in fulfilling the international obligations of the Republic of Uzbekistan in the field of human rights. The center is also funded by the State Budget of the Republic of Uzbekistan, international organizations and other institutions, grants from foreign organizations and other sources not prohibited by law.

The main tasks of the center are:

1. Facilitate the effective implementation of state policy in the field of human rights, the activities of state bodies of the Republic of Uzbekistan in the implementation of international obligations in this area;

2. To study, analyze and summarize the state of observance of human rights and freedoms, to monitor the implementation of the recommendations of international and regional human rights structures;

3. Preparation of national reports on the observance and protection of human rights in the Republic of Uzbekistan, development of national action plans for the implementation of the recommendations of international and regional human rights structures.

The Head of State has developed measures to improve the activities of the center. In particular, on December 10, 2018, the President of the Republic of Uzbekistan Shavkat Mirziyoyev signed a resolution "On improving the activities of the National Center for Human Rights of the Republic of Uzbekistan."
